### LAA2: List of Changes to Feb 2009 Refresh Update Report

This document highlights changes made to Luton's LAA2 agreement since the Secretary of State signed off the original in July 2008. There are generally two types of changes that have been made to the LAA; the first are changes made during the past 6 months where information wasn't known at the time of agreeing the LAA, such as certain indicator baselines (b/l's) based on outcomes of surveys. The other type is as a result of Feb 09 refresh, giving Luton the opportunity to set targets for indicators now that baselines are available and to renegotiate targets impacted by the economic downturn.

Both LAA priority and locally selected LAA indicators are included.
