# 80 APPLICATION FOR VARIATION OF PREMISES LICENCE – BARRELS, 59 CANNON LANE, LUTON (REF: 8)

The Chair introduced the Members of the Panel and Officers to those parties present.

The Licensing Manager's Representative reported on an application by Punch Taverns Plc, for the Variation of a Premises Licence in respect of Barrels, 59 Cannon Lane, Luton and outlined the variation requested in respect of the replacement of conditions listed on the current premises licence. She further reported on 4 objections to the variation of the Licence received from an interested party in relation to the additional hours and activities.

The Applicant's representative referred to a letter circulated at the meeting which had been sent from solicitors acting on behalf of Punch Taverns Plc to the local residents. The letter stated that their clients were willing to have a further condition imposed on the licence to prohibit the consumption of alcohol, food and any other licensable activities in the outside area after 11.00pm. He confirmed that variation of Conditions 5 and 9 should remain as detailed in the application form and that hours set out in condition 6 should be amended as follows:

"Designated premises supervisor to use all reasonable endeavours to remove customers and /or visitors from any outside areas after 23.00 hours, other than for the purposes of entering or leaving the premises"

Bedfordshire Police had submitted an objection to the variation of the premises licence however, through correspondence with the applicant's solicitor it had been agreed that no change would be sought to conditions 5 and 9 of the current licence and that condition 6 would be amended. On this basis Bedfordshire Police had withdrawn their representation.

In light of the proposed amendment as now put forward by the Applicant's agent Bedfordshire Police requested that their original representation be re-instated.

The Panel questioned all parties and all parties raised questions and responded to each other in compliance with the approved Procedure.

**Resolved:** That consideration of this matter take place following consideration of the passing of a resolution to exclude the public and press from the meeting.
