Annex 1 - Mandatory conditions

- 1. Where a premises licence authorises the supply of alcohol:
 - a) No supply of alcohol may be made under the premises licence
 - i. at a time when there is no designated premises supervisor in respect of the premises licence, or
 - ii. at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
 - b) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 2. Where a premises licence authorises the exhibition of films, the admission of children to the exhibition of any film is to be restricted in accordance with the following
 - a) Where the film classification body is specified, unless subsection (b)(ii) applies, admission of children must be restricted in accordance with any recommendation made by that body.
 - a) Admission of children must be restricted in accordance with any recommendation made by that licensing authority, where
 - i. the film classification body is not specified in the licence, or
 - i. the relevant licensing authority has notified the holder of the licence that this subsection applies to the film in question,
 - b) In this section
 - i. "children" means persons aged under 18; and
 - i. "film classification body" means the person or persons designated as the authority under section 4 of the Video Recordings Act 1984 (c.39) (authority to determine suitability of video works for classification).

FURTHER MANDATORY LICENSING CONDITIONS

With effect from 6 April 2010

- (1) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children—
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to—
- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or(ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;
- (d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on—
- (i) the outcome of a race, competition or other event or process, or
- (ii) the likelihood of anything occurring or not occurring;

With effect from 1 October 2010

- 4.— (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
- (2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.
- 5. The responsible person shall ensure that-
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—

 (i) beer or cider: ½ pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml; and
- (b) customers are made aware of the availability of these measures.

Annex 2 - Conditions consistent with the operating Schedule

- Intoxicating liquor shall not be sold or supplied on the premises otherwise than to persons taking table meals there and for consumption by such a person as an ancillary to his meals.
- 2. That suitable beverages other than intoxicating liquor (including drinking water) shall be equally available for consumption with or otherwise as an ancillary to meals served on the premises.
- 3. Not to admit any person carrying open or sealed bottles or glasses on to the premises at any time.
- 4. Not to permit any person to take open containers of alcoholic or soft drinks from the premises.
- 5. All bottles and glasses to be removed from public areas and tables as soon as they are finished with or are empty.
- 6. The management to ensure that at any given time the number of persons permitted in the restaurant does not exceed the capacity limit.
- 7. There are to be no irresponsible drinking promotions.
- 8. A large group policy to be in place, whereby they are required to nominate a responsible person to liaise with staff.
- 9. Alcohol is not to be served to any person under the age of 18 years. A proof of age policy to be in place.
- 10. An Incident book to be maintained, to record the details of all public disorder incidences.
- 11. All Exit doors to be easily opened without the use of a key, card or code.
- 12. All means of escape routes to be maintained and kept free from obstruction at all times.
- 13. Fire Exit doors to be clearly marked and all escape routes to be clearly identifiable.
- 14. All doors to be regularly checked and maintained in satisfactory working order.
- 15. Access for Emergency vehicles to remain clear and free from obstruction.
- 16. An Emergency Action Plan to be in place to ensure the safe evacuation of the premises and arrangements in the event of an emergency.
- 17. The Fire Brigade to be called to any outbreak of fire when disabled persons are on the premises, adequate arrangements are to be made to ensure their safe evacuation in the event of an emergency.
- 18. To ensure an adequate and appropriate supply of First Aid equipment and materials to be available on the premises at all times.
- 19. There is to be no smoking at the bar. Designated non-smoking area to remain.

- 20. Groups with children to be given priority to dine in the non-smoking area of the restaurant.
- 21. Offensive odours are not to be omitted beyond the boundary of the premises.
- 22. Flashing of bright lights to be placed in positions that do not cause a nuisance to neighbours.
- 23. Noise levels to be kept to a minimum.
- 24. Management to ensure that loitering outside the premises does not take place.

Conditions agreed by Police Licensing Officer

- The premises to adopt a Challenge 21 Policy whereby persons purchasing alcoholic drinks or who are having such drinks purchased for them who appear to be under the age of 21 will be asked to prove that they over the age of 18. The only acceptable forms of identification will be a bona fide passport, a photo-style driving licence or an ID card displaying the PASS hologram logo
- 2. To assist in the prevention of Crime & Disorder there will be no promotions that will encourage irresponsible drinking
- 3. CCTV must be in operation during the hours of opening and retained for 30 days.
- 4. All staff that are involved with the supply of alcohol, at the premises, be holders of a personal licence OR be trained in accordance with the BIIAB handbook for Personal Licence Holders or awareness in responsible alcohol retailing. A record of training to be kept and made available to the Police and Licensing Authority
- 5. A security alarm must be fitted.
- 6. Off sales of alcohol can only be made when proof of age is produced at the point of sale.
