<u>PURPOSE</u>

1. The purpose of this report is to submit to all of the scrutiny committees, the report of the Head of Corporate Finance and the Head of Capital and Asset Management to the Executive on the prospects for the Council's budget for the forthcoming and subsequent years, and the changes that have been made to the way in which the budget is developed and the evidence on which it is based (Appendix 1). It also provides an opportunity for the Corporate Directors to brief the committees about key issues and major projects and for Members to ask Directors and Heads of Services about budget pressures and their plans for the development and improvement of services, both in terms of service standards and value for money.

RECOMMENDATION(S)

2. (i) Environment and Non Executive Functions Scrutiny Committee is recommended to adopt the budget scrutiny protocol set out as appendix B of the report attached as Appendix 1.

- (ii) The Committees are recommended to consider the report, invite Heads of Service to comment on current year budget pressures and to indicate the challenges and opportunities facing their services in the forthcoming year and ask questions in order to gain an understanding of the position as work begins on preparing the budget.
- (iii) The committees are also recommended to receive briefings from the Corporate Directors about key issues and major projects.

BACKGROUND

3. In recent years there has been a protocol agreed between Executive and Scrutiny governing the process by which the Council's budget has been scrutinised. The first stage in the process is this opportunity for the committees to gain an understanding of the Council's financial position and the outlook for next year and to have an input at the very beginning of the preparation of the next budget.

<u>REPORT</u>

- 4. Attached as an appendix is the report of the Head of Corporate Finance and Procurement and the Head of Capital and Asset Management to the Executive on the Council's budget strategy for 2009-10 and future years. The report includes at appendix B a draft protocol for scrutinising the budget for the forthcoming year as it is developed. The protocol is identical to the one that was applied to the budget process last year except for the dates of meetings, which have been changed to reflect the approved programme of meetings for 2008-09. I will report orally on the decision of the Executive relating to the adoption of the protocol for this year's budget process.
- 5. Heads of Service have been invited to attend so that they can apprise the committees of any challenges they anticipate in framing the budgets for their services. The disposition of Heads of Service in relation to scrutiny committees for budget scrutiny purposes has previously been agreed by the Scrutiny Board. The arrangements for this year are as set out in the following table:
