# **PURPOSE**

1. The purpose of this report is to enable the Licensing Panel to consider the application received from Shila Morimoto, for the variation of a Premises Licence in respect of Bar Espresso 39-41 New Bedford Road Luton.

#### RECOMMENDATION

2. That the Licensing Panel determine the application of Shila Morimoto for the variation of a Premises Licence in respect of Bar Espresso, 39-41 New Bedford Road, Luton.

#### BACKGROUND

- 3. An application was received on 23<sup>rd</sup> December 2011 for the variation of the Premises Licence that will allow regulated entertainment, supply of alcohol on and off the premises and late night refreshment to take place.
- 4. The Applicant states that the premises is a coffee/bar/cafe, located on New Bedford Road in the Biscot Ward (on the edge of South Ward). A map showing the location of this Premises, along with an aerial image, and a plan of the premises submitted by the applicant, is attached at Appendix A (page 7/12).

9. The applicant has requested that the following conditions, terms or restrictions currently imposed on the licence be removed/amended as a consequence of the variation being sought:

# Annex 2: Conditions requesting to be removed

**CONDITION 1 –** Intoxicating liquor shall not be sold or supplied on the premises otherwise than to persons taking table meals there and for consumption by such a person as an ancillary to his meals.

**CONDITION 2** – That suitable beverages other than intoxicating liquor (including drinking water) shall be equally available for consumption with or otherwise as an ancillary to meals served on the premises.

**CONDITION 3 –** Not to admit any person carrying open or sealed bottles or glasses on to the premises at any time.

**CONDITION 4 –** Not to permit any person to take open containers of alcoholic or soft drinks from the premises.

**CONDITION 5 –** All bottles and glasses to be removed from public areas and tables as soon as they are finished with or are empty.

**CONDITION 8 –** A large group policy to be in place, whereby they are required to nominate a responsible person to liaise with staff.

**CONDITION 17** – The Fire Brigade to be called to any outbreak of fire when disabled persons are on the premises, adequate arrangements are to be made to ensure their safe evacuation in the event of an emergency.

**CONDITION 19 –** There is to be no smoking at the bar. Designated non-smoking area to remain.

**CONDITION 20 –** Groups with children to be given priority to dine in the non-smoking area of the restaurant.

**CONDITION 24 –** Management to ensure that loitering outside the premises does not take place.

The applicant has requested that the following conditions to be amended;

**CONDITION 6 -** The management to ensure that at any given time the number of persons permitted in the restaurant does not exceed the capacity limit.

Amend to read – Management to ensure capacity is not exceeded

## **Conditions agreed by Police Licensing Officer**

Condition 1 - The premises to adopt a Challenge 21 Policy whereby persons purchasing alcoholic drinks or who are having such drinks purchased for them who appear to be under the age of 21 will be asked to prove that they over the age of 18. The only acceptable forms of identification will be a bona fide passport, a photo-style driving licence or an ID card displaying the PASS hologram logo.

Applicant is requesting to amend the Challenge 21 Policy to Challenge 25.
