#### **PURPOSE**

 The purpose of this report is to invite the Committee to consider the called-in decision of the Executive in relation to Petition – Housing Services (Executive Decision No. EX/66/07).

### **RECOMMENDATION(S)**

(c) To refer the decisions to the Council for debate.
