The project started with a report to Executive on 10th September 2012. The request was to get a steer in order to consult on day services for people with learning disabilities. There was also some discussion on location of services for respite and day care on the same site. A number of models were up for discussion and this was developed to create one model to consult on, based on the principles given in the Outline Business Case (July 2012). Final agreement is sought on 25th March 2013 from Executives for an agreement and a model of future provision of day care. At this time we are not able to fully state what the impact will be as more detailed profiling will take place following Executive approval on the model. The model and any changes to job description can only be fully analysed when this is clearly known.

A consultation and IIA has been undertaken on respite services, however we will undertake a new IIA at a later stage including effect on customers.

These proposals will affect all adults with a learning disability accessing day services, particularly those at Bramingham day centre. It will also have an impact on the service delivery for young people coming through transition services.

130 customers in total (* includes Bramingham customers and those in receipt of day care from New Horizons – original figures in the outline business case stated 139 customers, however the figures fluctuate as people e.g. move out of the area).

We are aware of a projected figure of 96 young people coming through transitions in the next 5 years (aged 13-17). Information was gathered about the needs of these individuals and future aspirations from transitions service and the carers of young people. Young people will be encouraged to input their ideas about how they would like their day service to be delivered in the next phase. Direct input from young people will be gathered through the assessment and care planning process.

The project received a significant amount of support from the Consultation Team. This was to ensure the proposal was approved by the 'Ethics Committee'; That the project group worked in line with the 'Gunning Principles' throughout consultation process and in the development of a series of questionnaires for carers of people who use services, carers of individuals in transitions and carers who are currently accessing non-LBC day services

Following a decision from Executive in September to allow the project group to consult on day services for people with a learning disability, the consultation programme started with a report to the Learning Disability Partnership Board. A number of consultation sessions were held over a 3 month period in order to take account of the views of customers who currently use services, carers, staff and other key stakeholders e.g. residential care providers.

The consultation included the following:

- Briefing sessions for:
 - Customers (people who use services)
 - o Carers
 - Stakeholders and
 - o Staff
- Café events for
 - Customers
 - o Carers
 - Stake holders and
 - Staff
- Questionnaires were sent to carers of individuals using day services; carers of young people in transition and carers of individuals who receive day services form an external provider. In total 284 questionnaires were distributed.
- A profiling exercise of detailing the needs of each customer that is currently in receipt of day services and of those young people that will transition into the service over the next 5 years was carried out.

The consultation was supported by the Corporate Consultation team and undertaken in accordance with the Gunning principles. Carers and customers have been supported through the process by advocacy services.

All customers were made aware of the consultation A total of 155 people attended the briefing sessions and 126 people in total came to one of the café events. In total 78 questionnaires were returned. As response rates were generally considered to be low, this figure was achieved by a number of follow up telephone calls being made to carers.

The overall conclusion from the contributors to the consultation process was that there was support for a move to community-based service with only those with the complex needs or

challenging behaviours continuing in a building based project, providing there is a good transport process and that there is continuity of support. No specific sites were discussed, however, the limitations of the Bramingham Centre were noted and there was no strong opposition to moving to new locations. Separate bases for the complex health needs and challenging behaviour groups were favoured and there is general support for the co-location of the day centre for adults with complex needs with the new respite unit.

The majority of carers responses were from those of people with complex needs who would remain in a building based service and, therefore, it will be essential in the next phase of the project to ensure that customers and carers with moderate needs that will move to the community based service are fully involved in the development of the service and in planning their individual care programmes.

In relation to profiling, this has provided a general indication of the numbers for each element of the service and the potential activities that will be required, however, it is essential that this information is robust and, therefore, it is proposed to undertake independent assessments to verify the result of the profiling.

Customers will have greater opportunity to access community resources and facilities. The service will enable more people with a learning disability to utilise local day services where otherwise they would need to access day care outside of Luton. Keeping people safe will be a priority.

Whilst it is felt the final outcome would be positive on the lives of people with learning disabilities and their carers, it is recognised that whole sale change can cause anxiety, particularly for those with specific disorders i.e. Autism. Also there are a large number of customers who are in their late 50's and we need to recognise that people with a learning disabilities can present with ill health that is associated with those who are much older in the community. There are more customers from a White British background. It is also acknowledged that some carers may find the transition to a new model challenging and the project groups need to be sensitive to this.

There will be an impact on inclusion; the final outcome is on integration, independence and choice recognising that customers will also have the ability through direct payment to consider where to have day care. There are clear areas of customer need at present which can be broadly broken down by Autistic Spectrum / Challenging behaviours / Dual diagnosis / Profound and Complex / Sensory / Mild to Moderate and those within New Horizon pathways(i.e. employment and volunteer opportunities), all of whom are stakeholders. We also recognise that, as well as present needs, there are increasing needs with 96 customers coming through transition from Children's Services in the next 5 years. Over 60% of customers in the future requiring support will have complex needs.

Summary of Findings and Actions (for publication and to be written by the author)

Following the consultation process, the review of the IIA illustrates that the recommendation to create specialist services and in particular a new build from which some people will receive

a service was positively received.

The recommendation to also create a community model to enable customers to access local facilities was supported on the basis that issues such as transport and continuity of care are appropriately addressed. Officers have given a commitment that these concerns will be incorporated into the work plan through specific work streams.

A full business plan to facilitate the infrastructure of the community model needs to be written in the next phase of the project, if approval is given to the recommendations by Executive.
