#### **PURPOSE**

1. To ask the Race Advisory Forum to nominate a community representative to the School Organisation Committee.

## **RECOMMENDATION(S)**

### **BACKGROUND**

3. The School Organisation Committee is central to the arrangements for local decision making introduced by the School Standards and Framework Act 1998. It is not a committee of the local authority. It is a separate statutory body which brings together the key partners in the provision of education at a local level, giving each an equal voice. It takes decisions on school organisation proposals (e.g. school mergers and closures) and keeps an overview on the supply and demand for school places in Luton.
