63. APPLICATION FOR THE VARIATION OF PREMISES LICENCE: HIGH TOWN NEWSAGENT – 8 HIGH TOWN ROAD, LUTON (REF: 6)

The Licensing Manager's representative reported on an application received from Mr Zaheer Mahmood for the variation of a premises licence, in respect of High Town Newsagent, 8 High Town Road, Luton that will allow an extension of their existing hours for the supply of alcohol to take place.

The Licensing Manager's representative further reported on two written representations relating to the Licensing Objectives, one from Bedfordshire Police, a Responsible Authority and one from Ward Councillor Andrew Malcolm. PC Read and Cllr Malcolm were in attendance as listed above.

The Licensing Manager's representative additionally reported on one incident relating to the licensed premises, when illegal cigarettes and tobacco on sale at the premises were removed by Trading Standards in February 2014.

There were no questions from the Panel for the Licensing Manager's representative.

PC Read made her representation on the application, requesting the application be refused for the reasons stated in her report (Ref: 6, pages 6/30 - 6/33), highlighting a number of key points as follows:

- The Police objection was based on the prevention of crime and disorder and public nuisance licensing objectives;
- The area was a hot spot for the street sex workers and kerb crawlers, which the Police and the Council had been working together to tackle;
- Since 2013, 193 men had been detained for kerb crawling and 98 arrested for other offences. The Police were also receiving up to 34 complaints a month;
- 24 hours opening for the premises was likely to encourage crime and disorder and public nuisance;
- Although describing itself as a 'Newsagent', no newspapers were on sale at the premises, but super strength alcohol was on sale;
- The Applicant had been hostile and not prepared to discuss alternative opening hours, blaming the Police for crime in the area;
- The premises had been subject of Trading Standards action for selling illegal cigarettes and tobacco.

PC Read was questioned by the Panel and responded in compliance with the approved procedure, providing further clarification as follows:

- Other licensed premises in the area with late opening hours employed door staff and drinking took place on premises, not outside;
- Super strength alcohol was on sale at the premises;
- Police attention in the area normally ended around 1.00 a.m. / 2.00 a.m.

Cllr Malcolm made his representation on the application, highlighting a number of key points as follows:

- His objection as Ward Councillor was based on all the four licensing objectives as set out in his letter;
- Tackling the area street sex trade was a top priority for the community, identified from consultation, as part of the 'Your Say, Your Way' Community Development programme;
- The community views needed to be taken seriously;
- There were precedents as previous applications for 24 hour opening hours from 3 other premises in the area had been refused;

• If the Panel should consider allowing the application, he suggested the hours should be similar to other premises in the area.

There were no questions from the Panel for Cllr Malcolm.

PC Read added that if the Panel were to consider an extension to the current opening hours, then 1.00 a.m. would be acceptable to the Police.

The Clerk to the Panel advised the Panel that in accordance with the Guidance issued under the Licensing Act, the Police, a Responsible Authority, was an essential source of information about the impact on the Crime and Disorder objective. With their key role in managing the night time economy, they were the main source of advice and entitled to make representations based on evidence. The Local Authority should accept all reasonable suggestions from them unless not in support of the licensing objectives.

The Applicant arrived at 11.50 a.m.

The Chair explained to the Applicant the stage at which the meeting was and gave him the opportunity to ask questions of the Police and Councillor Malcolm.

PC Read was questioned by the Applicant and responded in compliance with the approved procedure, providing information summarised as follows:

- Police opposition to the application was explained to the Applicant during visit to the premises, but she claimed he did not accept advice;
- High Town was a high density residential area, with busy traffic and affected by street sex workers, which the authorities had been trying to tackle;
- There were concerns late opening would encourage more people to the area, as usually there was not a lot of people in the area late at night;
- There was a 5 year Plan to make High Town a safer area. The fear was that late opening and alcohol would encourage more crime and disorder;
- Since January 2013, 193 men had been detained for kerb crawling, 98 arrested for other offences and the Police received up to 34 complaints a month;
- No information was available exactly where the arrests were made;
- Street sex workers worked up and down High Town Road.

The Applicant made his representation in support of his application, highlighting key points as follows:

- He lived in the area and had not seen any problems;
- He had worked as a taxi controller on nights next door to the shop and had not seen any problems with sex workers in High Town Road;
- There was CCTV camera cover at the bottom of High Town Road.

The Panel invited all parties to make any final representations, but there were none.

The Panel had considered the papers before it including the oral and written representations made by the Applicant, PC Read and Cllr Malcolm. In addition the Panel had regard to the licensing objectives set out in the Licensing Act 2003 (the Act), the Council's Statement of Licensing Policy and the Guidance issued under the Act.

Resolved: That the application received from Mr Zaheer Mahmood for the variation of a premises licence, in respect of High Town Newsagent, 8 High Town Road, Luton that will allow an extension of their existing hours for the supply of alcohol to take place, be **REFUSED.**

The Panel determined that granting the application would cause nuisance to those living in the vicinity due to the number of additional people who would be drawn to the premises and area during the early hours of the morning to purchase alcohol and the associated noise and public nuisance that would be generated.

The Panel also determined there was the potential for an impact on the crime and disorder objective as a result of the later hours, having regard to the representation made by the Police about the on-going problems with street sex workers and kerb crawlers in the area.



Our objection comes from the Prevention of Crime and Disorder section of the Licensing Objectives defined in the Licensing Act 2003.

High Town Road is a main street situated in the High Town area of Luton. It is a road that runs from Midland Road in to a small high street with shops and surrounding residential streets. It is close to Luton Train Station.

High Town is used by women working in the sex trade, High Town Road and some of the side streets leading off High Town Road are assocaited with this illegal activity. In 2013 the Police had to take a proactive response to the kerb crawlers in this area. A Police Operation, which is still on-going, was set up to focus on the area to tackle this problem of sex workers and antisocial behaviour. Since January 2013 there have been 193 men detained for kerb crawling. A futher 98 have been arrested for other offences. During the winter months residents complaints have dropped to approx 7 a month, however in the warmer months Police were receiving up to 34 complaints a month. We have received 4 phone calls in the last month reporting Anti-social behaviour, 2 of which related to Sex Workers in High Town.

The Police are working with Luton Borough Council and the Health service to put a 5 year strategy in place to deal with the sex trade in Luton .

The granting of a alcohol licence for the shop from 6am until 2am could be significant in attracting more sex workers into the area as they may loiter near to the shop and approach customers who go to the shop late at night.

Whilst the Police understand that JJ Food Store are wanting to run a business the crime that it could encourgage late at night is of a concern. We wish to prevent futher offences of anti-social behaviour and the sex trade by requesting that a licence for 6am until 2am is refused. There are no other shops in the direct vacinity open this late, the off licence near to this shop has a licence until 23:00 hours.

The hours on the current licence for the premises are acceptable. The applicant has given consideration to Challenge 25, CCTV however we are keen to promote that CCTV is kept for 31 days instead of the 28 which is on the application. All applications are treated seperately , but using the statistics available to Police at this current time the Police operation and health service operation in the area have been making a difference in reducing anti-social behaviour and want this to be able to conitinue. A licence that goes into the night could affect the work committed to the area.

Proposal: Variation of Premises licence to extend the sale of alcohol hours to Monday to Sunday 06:00 to 02:00 (the following day) Remove any conditions embedded on the licence carried forward by the grandfather rights and to Amend the current premises plan showing the new shop front relocation.

This is an objection in reference to the application by High Town Newsagents for 8 High Town Road to supply alcohol 24 hours a day, seven days a week. I would like to raise the following concerns by way of formal objection:

1. Crime and Disorder.

A alcohol supply licence from 6am to 2am the following day will draw unwelcome attention and increased footfall at unsociable hours to a residential and conservation area.

Noise, public nuisance, anti-social behaviour, low-level nuisance (non reportable crime inc. shouting, swearing, urination in public, littering) will be increased.

The site is located on High Town road, historically the street sex trade has been located in this area and has caused disturbance to residents. Police attention to this issue has largely curbed this, however, the site is acknowledged by the Police to be of concern and crime, antisocial behaviour, prostitution, begging and street drinking continue to be of great concern to residents when reporting at community events.

2. Public Nuisance.

20 hour supply of alcohol in an area where residential properties are located will unnecessarily draw people from a wider area at unsociable hours.

Noise, light pollution, traffic and traffic noise will all have a negative impact.

As far as I am aware there is no parking at this site and any additional traffic will therefore have implications for the road network and local residents.

3. Public Safety.

A 20 hour alcohol supply licence will likely draw in unwelcome attention as described above and will therefore impact upon public safety in the locality and upon perceptions of safety which are just as important when considering the quality of living in an area.

4. The Protection of Children From Harm.

The licence conflicts with the amenities available to children in the area, putting them at risk from anti-social behaviour, increased littering, rodent and fox infestations, exposure to the marketing and sale of alcohol and cigarettes, increased potential for road traffic incidents.

Thank you for taking the time to seriously consider these objections.

I am writing in my capacity as Chair of the residents association for High Town ward, known as the Friends of High Town (FoHT).

We are a body recognised by Luton Borough Council in consultation matters.

The application reference above for a Variation of the Premises License, to extend the hours permitted for selling alcohol, was brought to our attention at our last monthly meeting.

FoHT voted to oppose this application on the grounds of:

- a) Prevention of crime and disorder
- b) Prevention of public nuisance
- c) Public safety.

There are existing anti-social behaviour problems with a small number of street drinkers around the main shopping area of High Town Road. They often congregate on the bench close to the junction with Burr Street, where they drink to excess, shout, swear, spit and leave litter. Members of our group feel they have to cross the road to avoid them.

The same problems are associated with a number of people who live in or frequent flats on Burr Street at the junction with High Town Road.

Representations have also been made to FoHT about people consuming alcohol bought in the area, who then urinate in nearby streets and alleyways, and in some cases defecate in nearby alleyways.

In the last year or more, a number of young men have parked in cars with dark tinted windows opposite 1 High Town Road from late afternoon into the night and have been engaged in suspicious activity, involving entering the premises in question. Members of the Bedfordshire Police Safer Neighbourhood Team have been informed about this in the recent past.

The Crime Map for the High Town policing area shows a steady increase in anti-social behaviour from December 2013 to May 2014 inclusive (the last available figures). FoHT feels this could be exacerbated by extending the hours for alcohol sales from JJ Foodstore.

I have supplied the address for our monthly meetings, as this is a group representation. However, I would like to make it very clear that the High Town Methodist Church is not to be associated with the opinions expressed within this email.

I would like to raise an objection to the Variation of Premises Licence application LA03/High Town Food & Beverages/137357 from 1 High Town Road to extend the supply of alcohol for consumption on the premises to 06:00 to 02:00. I do not believe that the premises would meet the licensing objectives, and so I ask you to refuse this application for the reasons detailed below.

The main concerns are that High Town Road is used by drug dealers, which attracts women working in the sex trade. Luton Borough Council are working with the Police are working with Luton Borough Council and the Health service to put a 5 year strategy in place to deal with the sex trade in Luton . 2013 the Police had to take a proactive response to the kerb crawlers in this area. A Police Operation, which is still on-going, was set up to focus on the area to tackle this problem of sex workers and anti-social behaviour. Since January 2013 there have been 193 men detained for kerb crawling. A futher 98 have been arrested for other offences. As High Town ward councillor for the last three years I have been contacted repeatedly by residents in and around High Town Road who have complained about antisocial behaviour, drug dealing and noise nuisance at that end of the road. I have raised these concerns with the Police, the Council environment officers and the ASB priority team, who are all aware of the problems in the location and with the store, which are exacerbated by other criminal activity in the area.

The granting of a alcohol licence for the shop from 6am until 2am could be significant in attracting more sex workers into the area as they may loiter near to the shop and approach customers who go to the shop late at night.

Whilst I understand that the applicant wants to run a business, the crime that it could encourage late at night is a concern. There are no other shops in the direct vicinity open this late, the off licence near to this shop has a licence until 23:00 hours.

St Matthew's are writing to object to the application for the Variation of Premises Licence for High Town Food and Beverages, 1 High Town Road, Luton.

St Matthew's schools over 800 students. Many of these students and their families walk to school through High Town Road, directly past the premises in question. From 8.30 am to 9.15 am and from 3pm to 3.45 pm the road has hundreds of parents with young families walking up and down it, to and from the school.

With this in mind, we believe that allowing this licence would not be in the interest of the following licensing objectives:

- Prevention of Crime and Disorder: In High Town, there are a small number of individuals and groups who exhibit anti-social behavior.
 Allowing alcohol to be purchased for longer hours will exacerbate and give more opportunity for anti-social and criminal behavior that the school and the community works hard to minimise.
- 2. Public Safety: Allowing alcohol to be purchased during the hours requested is likely to bring rise to further drunken and disorderly behavior. This in turn puts the safety of those who attend our school at risk.
- 3. Prevention of Public Nuisance: Allowing alcohol to be purchased during the hours requested is likely to bring rise to further drunken and disorderly behavior. This in turn creates a nuisance for the community and our families who walk past the premises every school day.
- 4. Protection of Children from Harm. Allowing alcohol to be purchased during the hours requested is likely to bring rise to further drunken and disorderly behavior. As a result, children who attend St Matthew's will be at increased risk of being harmed by someone under the influence of alcohol. Given the close proximity of the school in relation to the premises which has requested the licence and the number of families who walk past it every day, to allow such a license could directly result in the harm of our students.

In summary of the four objections raised, granting such a licence would put children and their families who walk to St Matthew's Primary School; at

greater risk of the disruption, inconveniences and trauma caused from crime and disorder; at greater risk of nuisance and at greater risk of harm. Therefore, granting this license would be irresponsible and detrimental to the community.
