#### **BACKGROUND**

3. Best Value Scrutiny Committee considered the Regeneration Best Value Review Scope and Project Plan at its meeting on 1<sup>st</sup> March 2005.

#### **REPORT**

- 4. The Regeneration Service Best Value Project Team set up 5 sub groups Compare, Consult, Challenge, Finance, and Compete which carried out research into the 5 Key Issues of: Deprivation, Environment, Economy, Funding and Regeneration Roles. Results of the research are shown in the Appendix Section of the Vision Report (at Appendix A).
- 5. As a result of the research, the Regeneration Best Value Project Team has produced a vision for the Regeneration Service in the future, showing more and less that could be done under the Key Issues.
- 6. A major part of the Vision is the "Regeneration Champion" model where Regeneration staff would bring together partners (including Council departments) to fulfil the strategic needs arising from Regeneration issues. These teams would then engage partners to deliver, or if there was a gap, Regeneration Service itself would deliver activities.

## PROPOSAL/OPTION

7. Best Value Scrutiny is invited to give comments on the Regeneration Service Best Value Review's Vision Report.

## **LEGAL IMPLICATIONS**
