# **RECOMMENDATION(S)**

#### **REPORT**

2. At its meeting on the 21<sup>st</sup> January 2009 Environment and Non Executive Functions Scrutiny Committee received a report from The Principal Climate Change Officer informing the Committee that the Council must comply with

the Carbon Reduction Commitment as it involved a financial penalty for noncompliance of 10% of its annual energy spend from 2010. This penalty was likely to increase each year.

- 3. The Committee were informed that climate change was a fairly new issue and agenda for both officers and Members, and there was nothing specific in writing at the present time. The Head of Engineering and Transportation as Chair of the Luton Climate Change Group would be promoting work, starting developments, improving appropriate policies and engaging with Members and Officers.
- 4. Members recommended that the Executive considers approval for an environmental implications paragraph to be included on all future committee reports.
- 5. Environment and Non Executive Functions Scrutiny Committee resolved:-

"That the Executive be requested to include an Environmental clearance paragraph on all future Committee reports."
