12. NOTICE OF MOTION

1. To consider the following motion of which notice has been given in accordance with Standing Order 13.1 signed by Councillor Simmons:

Luton Borough Council is aware that three people from Luton were among the Construction Industry workers who were "blacklisted" for their Trade Union and health and safety activities. Blacklisting is a malicious and unacceptable practice and cannot be condoned. Construction workers should be free to belong to a Trade Union and raise legitimate safety concerns in what is a hazardous industry. Blacklisting has ruined careers and lives, not only of construction workers but also those of their families.

The Council deplores this "blacklisting" and fully supports the campaign by the GMB Union for justice and compensation for the workers affected. The Council will not award new contracts to companies that are known to be acting illegally with respect to employment or health and safety legislation, subject to the ensuring that this approach itself complies with the law.
