PURPOSE

1. To bring before the committee an update on the issues that were raised following the last Area Committee held on the 9th June 2008

RECOMMENDATION(S)

2. The West Luton Area Committee are recommended to note the report and make recommendations on further action where required.

BACKGROUND

3. This report encapsulates the progress of the area committee since the implementation of the initiative in October 2001. In addition it includes information on projects and activities supported by the committee and following liaison and mediation with both internal and external service

areas, pursues the concerns raised by both the local community and Members of the council.

REPORT

- 4. Members of the public who appear on the current database were informed of this meeting by post on the 17th September 2008 and publicity for this cycle of meetings appeared in the Luton News and Herald & Post during week commencing 1st September 2008 and in the Luton on Sunday on the 7th 21st September and the 4th October 2008. The area committees also have a regular feature in Lutonline, which Members will be aware is circulated across the town. Additionally a full page advert was taken in Lutonline during July/August offering information on how people can get involved with the area committee process and giving the dates of all the area committees for 2008/2009.
- 5. Additionally, posters in keeping with the new style advert and corporate approach to area committees were also dispatched to every General Practitioner, Dental Practice, Chiropodists, Chiropractors, Educational establishment, Library, Sports Centre, Community & Youth Centre, Day Centre, Places of Worship and Sheltered Housing provision, across the borough. The information gave dates for every Area Committee and was then followed up with specific information about the Area Committee, relevant to that area.
- 6. The Area Committee web site is regularly updated and can be accessed on www.luton.gov.uk/areacommittees

INTERIM REPORT IN NEIGHBOURHOOD GOVERNANCE & MANAGEMENT

- 7. Since my last report to the area committee on the subject of 'Neighbourhood Governance' a further meeting of the Area Committee Board took place on the 24th June 2008.
- 8. The Chief Executive presented a report on the recommendations of the Task and Finish Group on neighbourhood governance. The group had proposed a pilot scheme to develop neighbourhood governance. The group had recognised that such a pilot, if it were to be successful, would have resource implications for which there was no identified budget.
- 9. These proposals had been referred to the Labour and Liberal Democrat Council Groups for their comments. Although there had largely been consensus between the Groups on the proposals, there had been different suggestions for the length of the pilot, the area in which the pilot should be conducted and the speed with which budgets should be delegated.

- 10. The Chief Executive reported that officers would ideally like a timescale of 18 to 24 months. Officers did not have preconceived ideas what the structures should be and it was envisaged that appropriate structures would evolve with experience during the course of the pilot scheme.
- 11. The Chief Executive advised that it was envisaged that the Area Board should be the main reporting body for feedback for the pilot. He further advised that, although no detailed costing had been made, the likely cost of the pilot would be in the region of £50k.
- 12. The Chief Executive commented that the police already reported issues directly to the Area Committees. It might be possible for schools and the health services to report in a similar way. As an example, his experience in Hackney was that residents had appreciated direct feedback on the relative performance of local schools.

Resolved: (i) That the report (Ref: 8) be noted.

- (ii) That Executive be requested to instruct officers to scope and assess the financial and human resource requirements for the implementation of a neighbourhood governance 'pilot' scheme.
- (iii) That, subject to the Executive making the necessary resources available, a pilot scheme should be run in the area covered by the West Luton Area Committee and should run for at least 18 months so as to include a complete budget cycle.
- (iv) That the existing wards should be the basic units for the pilot scheme.
- (v) That the Board should receive a report on the pilot scheme in summer 2010.

LEAGRAVE RAILWAY STATION

- 13. The Area Committee Support Officer has been in discussion with the Traffic Engineering Manager regarding the parking situation at Leagrave Railway Station. It has been ascertained that the car parks situated in this area are managed by the 'First Group' on behalf of Network Rail, and therefore Luton Borough Council do not have any jurisdiction over these parking arrangements.
- 14. However, the Council are currently working in conjunction with the First Group, to make access improvements for pedestrians and people with disabilities on the Marsh Road side of the site.

15. In addition a letter was sent to the Rachael Borthwick, Group Corporate Communication Director, First Group plc on the 5th September 2008, inviting her or a representative to the meeting this evening but to date no communication to that invitation has been received.
