PURPOSE

1. To advise the Race Advisory Forum of the outcome of a recent membership review .

RECOMMENDATION(S)

- 2. RACE ADVISORY FORUM is recommended to;
 - i) consider this report and to decide whether they agree to the discontinuation of all future notification of forum meetings and posting of agendas and support papers to non responding organisations below.

ii) remove all non- responding and untraceable organisations from membership of the Race Advisory Forum.

BACKGROUND

3. The Race Advisory Forum (RAF) asked officers to undertake a membership review in order to identify organisations which had not sent representatives to meetings of the RAF for a year or more. Such a request was prompted by a number of considerations, not least by wishing to improve attendance at meetings and to save on postage by not sending meeting agendas and support papers to organisations which of late had demonstrated little commitment to attending meetings.

REPORT

4. Letters were sent to 28 local minority voluntary organisations drawing their attention to the fact that they had not attended RAF meetings for some time and asking them if they still wanted to continue to receive agendas and papers for future meetings. If so, then ,that would only be done if they offered a firm assurance of regular attendance at future meetings.
